**Article I: Name and Purpose**

1. Name: The name of this organization shall be RHS World Support Alliance.
2. Purpose: The purpose of the RHS World Support Alliance shall be to [The RHS World Support Alliance is a compassionate and dedicated club that is committed to making a difference in the lives of children worldwide. **Article II: Membership**

1. Eligibility: Membership in RHS World Support Alliance shall be open to all students of Ridgewood High School who express interest and adhere to the club's rules and regulations.
2. Rights and Responsibilities: All members shall have the right to participate in club activities and meetings. Members are expected to attend meetings regularly, contribute positively to the club's objectives, and uphold the reputation of the club and school.

**Article III: Officers**

2. Election and Term: Officers shall be elected by advisor vote.
3. Duties: Each officer shall have specific duties as outlined in the club's constitution or as assigned by the club advisor and club president. These duties shall be fulfilled to the best of their ability.

#### **Article IV: Meetings**

1. Regular Meetings: RHSWSA shall hold regular meetings 3 Times a month on Thursdays One leader meeting and 2 regular meetings to the club members.
2. Special Meetings: Special meetings may be called by the club president or upon the request of a majority of the club officers.

#### Article V: Finances

1. Budget: The club shall operate within a budget approved by the club president and advisor
2. Fundraising: Any fundraising activities must be approved by the club advisor and president and comply with school regulations.
3. Use of Funds: Club funds shall be used solely for purposes related to the club's mission and activities.

#### **Article VI: Amendments**

1. Proposal: Any member may propose amendments to these bylaws at a regular meeting.
2. Approval: Proposed amendments must be approved by the advisor and president and vice president vote of the club members present at the meeting.

#### **Article VII: Advisor**

1. Responsibilities: The advisor shall oversee club activities, ensure compliance with school policies, and assist in the development and execution of club initiatives.
